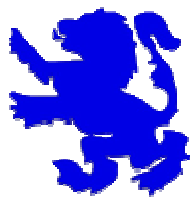


# Risk Assessed Management Plan

## **PRINCIPAL ACTIVITY TO BE CONDUCTED:**

To provide facilities to the players and supporters of the South Gawler Football club inc. and the Affiliated sporting bodies, as well as visiting players and supporters.

South Gawler Football Club inc. is a sporting club with membership open to all players and their friends and families. Visiting sporting clubs and their supporters are offered reciprocal membership. There is no takeaway alcohol, gambling or cigarette purchasing facilities.

## **THE MAXIMUM HOURS OF OPERATION:**

The South Gawler Football Club inc. is a holder of Club License no#50902113

The club can trade within the Licensed Hours:

Monday to Friday: 10:30am to 11:30pm

Saturday: 10:30am to 1:30am (the next day)

Game days - License boundary is deemed to be the boundary fence of the property. As shown on the appropriate map.

Sunday: 10.30 am to 7.30pm

(excluding Christmas Day, Good Friday the trading hours of which are prescribed in the Liquor licensing Act 1997)

## **RSA INITIATIVES:**

The South Gawler Football Club inc. is a Level 3 Good Sports Club.

Through the Good Sports Program, RSA courses are offered to members who volunteer serving alcohol.

Members with their RSA include but not limited to:

Volunteer workers must refuse alcohol to patrons who are unduly intoxicated.

## **DEALING WITH UNDULY INTOXICATED/DISORDILY PERSONS**

It is an offence to sell or supply liquor on licensed premises to a person who is intoxicated or in circumstances in which the person's speech, balance, coordination or behaviour is noticeably impaired and it is reasonable to believe that the impairment is the result of the consumption of liquor.

Volunteers should bring any incident of intoxication to a member of the Management Committee or Responsible Person (RP badged) so they can assess the

situation and provide appropriate direction, control or action. The Responsible Person will supervise the patron offering water and if need contact a taxi for the patrons benefit.

#### MINORS:

Parents and guardians at all times shall be responsible for the behavior of their children in the licensed area. Parents and guardians of children whose behavior is socially unacceptable shall be requested to remove them from the area.

Persons under the age of 18 shall not be permitted to be served or receive alcohol.

Persons under the age of 18 shall not be permitted to be to remain in the licensed area unless under the direct supervision of an adult who has parental rights and responsibilities for the minor from midnight till 5am the next day. Any unaccompanied minor shall be removed from the licensed area by a responsible person only and escorted back to their parents where necessary.

Liquor may not be sold or supplied to, or permitted to be consumed by a minor on licensed premises or at a place adjacent to the licensed area.

No Person shall purchase alcoholic drinks for minors

Persons may be asked for an acceptable proof of age card prior to service. The following photographic ID represents the only acceptable proof of age:-

- A proof of age card issued by relevant authorities in each territory or state. The proof of age card issued in South Australia is Card 18+
- A driver's license
- An Australian or foreign passport

Appropriate signage is to be displayed in prominent areas informing people of these facts is required.

#### **PARTICIPATION IN LOCAL LIQUOR ACCORD:**

South Gawler Football Club inc. is a community club and as such would abide by any local liquor accord where possible.

## **MITIGATING IMPACT OF BUSINESSES/RESIDENTS WITHIN THE AREA**

Due to location of the football club, there are no sensitive areas which may be impacted by the activities of the club.

### **SECURITY:**

South Gawler Football Club is a volunteer based club.

Conduct within the licensed area is the responsibility of the Management Committee. All members and visitors are requested to maintain an appropriate code of behavior and consider the needs of other patrons.

Members or visitors shall not bring liquor of any kind onto the licensed area

Swearing, loud and abusive language or excessive noise shall not be permitted near the licensed area.

At high crowd volume times professional crowd control personnel may be employed - Removal of patrons from premises to approved by the Responsible Person only.

### **PROVISION OF FOOD:**

Food will be available for purchase generally when the bar is open.

Usually a BBQ with sausages, steak, pies, pasties will be offered for sale.

Hot snacks are always available from behind the bar.

### **STAFF TRAINING:**

South Gawler Football Club inc is a volunteer based club.

All volunteers are required to obtain their RSA and familiarise themselves with Health and Hygiene Regulations.

At least 1 volunteer member trained in Responsible Service of Alcohol/Responsible person will be available to manage the sale of alcohol.

## **IF AMPLIFIED/OUTDOOR ENTERTAINMENT IS PROPOSED, HOW THE IMPACT ON THE SURROUNDING LOCALITY IS MITIGATED:**

Council approval/advice would be sought together with a limited license agreement as well with appropriate trading hours.
